THE 3rd ASIA-PACIFIC WOMAN ENTREPRENEUR AWARD

The Asia-Pacific Woman Entrepreneur Award is a project of the CACCI Women Entrepreneur Council (CWEC) under the Confederation of Asia-Pacific Chambers of Commerce and Industry.

The Award aims to recognize excellent women entrepreneurs in the Asia-Pacific rim who not only are successful in their business but also advocate corporate social responsibility for the good of their country. Conferred every two years by CACCI in conjunction with the CACCI Conference, the Award is open to women entrepreneurs nominated by any CACCI Primary Member.

SELECTION CRITERIA

- Must be engaged in her country-based or international-based profit organization that has been in existence for at least five years and actively involved in the global market
- Must be actively involved in business-related non-profit organizations
- Must exercise excellence in entrepreneurial and business leadership
- Must be regarded in her country with integrity and known for practicing good business ethics

The winner of the Award shall also be selected on the basis of her outstanding achievements in the following areas:

1. **Business Acumen** (40%)

Consideration is given to the ability of the candidate to take advantage of business opportunities, solve problems, set corporate directions and effectively implement plans (which include major strategies and tactical moves) to achieve corporate targets and objectives. This also considers the overall impact on the performance of the company in terms of profitability.

2. Involvement in Non-profit Business Organizations or Associations (25%)

Consideration is given to concrete achievements in corporate social responsibility as a result of the candidate's involvement in business and civic organizations. Consideration is given to the candidate's expertise shared through mentorship especially of other women entrepreneurs, programs initiated and implemented, and direct involvement in activities – including those of other business organizations - that benefit specific sectors and the country in general.

3. Leadership Qualities (20%)

Consideration is given to the ability of the candidate to steer her company and/or civic organization to a position of strength and stability. Quantitative and qualitative standards such as company performance for the last three years, corporate image/reputations, and awards and recognition earned by the company/organization under the candidate's leadership shall apply.

4. Integrity (15%)

Consideration is given to the candidate's background and character and how she is perceived by her peers and the community in her country; she must exhibit a commitment to honesty, fairness, objectivity and responsibility; and her company must be run ethically that express shared global concerns, values and standards.

NOMINATION RULES

1. The Asia-Pacific Women Entrepreneur Award is open to all Primary Members' affiliated local chambers of commerce and industry (town and city chambers).
2. Nominees qualified to participate are those nominated and endorsed by a Primary Member. Each Primary Member may submit at most **five** nominees from among the local entries, and submit the same to the CACCI Secretariat.
3. The timeframe of achievement shall cover the period from **January to December** of the year prior to the presentation of the Award.
4. The Primary Member must complete and sign the Official Nomination Form. The entries must be documented with an Executive Summary of not more than 800 words about the achievement of the woman entrepreneur nominee. It shall briefly state what she has achieved based on the given set of criteria.
5. The entries must be supported with the required documents specified in the Official Nomination Form.

SELECTION PROCESS

1. An Awards Committee shall be constituted by the CACCI Secretariat to evaluate the nominations. A **short-list of the five** most outstanding women entrepreneurs shall be made by the Awards Committee. The short list shall, in turn, be passed on to the

Board of Judges, which is composed of representatives of the Primary Members who are willing to serve in the Board. The short-list must be received by the Board of Judges at least a month prior to the date of the final selection process.

2. The nominee must:
 - a. Agree to abide by the rules and regulations of the CACCI Awards Committee;
 - b. Be willing to give additional information required by the Committee; and
 - c. Be willing to personally appear before the Board of Judges to make a presentation or for interview, if required; and receive the Award, if selected.

JUDGING RULES AND MECHANICS

1. Nominations together with the Executive Summary and support documents as stated in the Official Nomination Form must be received by the CACCI Secretariat by **April 30, 2020**, and delivered to the Awards Committee by **June 15, 2020**.
2. Five (5) members (with no two representing the same CACCI member country) shall compose the Board of Judges. All five (5) judges or their duly authorized representative must be present during the Final Judging Session in **late 2020**.
3. The short-listed nominees shall be evaluated by the Board of Judges using a weighted grading system. The Board's evaluation shall be made based on the supporting documents submitted by the nominees and, if necessary, through interviews of the nominees.
4. The winner shall be decided on the basis of the weighted grade. The nominee who receives the highest weighted grade based on the agreed criteria shall be declared the winner.
5. The Board of Judges' decision shall be final.

THE AWARD

2. In addition, each of the short-listed nominees shall be provided traveling allowance of not more than US\$500 to enable her to undergo the final selection process to be held a day before the CACCI Conference.

**THE 9th ASIA-PACIFIC
YOUNG ENTREPRENEUR AWARD**

The Asia-Pacific Young Entrepreneur Award is a project of the Young Entrepreneurs Group of Asia Pacific (YEGAP) of the Confederation of Asia-Pacific Chambers of Commerce and Industry (CACCI).

The Award aims to recognize excellent young entrepreneurs in the Asia-Pacific rim who not only are successful in their business but also advocate corporate social responsibility for the good of their country. Conferred every two years by CACCI in conjunction with the CACCI Conference, the Award is open to male or female entrepreneurs below 45 years of age nominated by any CACCI Primary Member.

SELECTION CRITERIA

- Male or female
- Below 45 years of age
- Must be engaged in his/her country-based or international-based profit organization
- Must be actively involved in business-related non-profit organizations
- Must exercise excellence in entrepreneurial and business leadership
- Must be regarded in his or her country with integrity and known for practicing good business ethics

The winner of the Award shall also be selected on the basis of his/her outstanding achievements in the following areas:

1. **Business Acumen (40%)**

Consideration is given to the ability of the candidate to take advantage of business opportunities, solve problems, set corporate directions and effectively implement plans (which include major strategies and tactical moves) to achieve corporate targets and objectives. This also considers the overall impact on the performance of the company in terms of profitability.

2. **Involvement in Non-profit Business Organizations or Associations (25%)**

Consideration is given to concrete achievements in corporate social responsibility as a result of the candidate's involvement in business and civic organizations. Consideration is given to the candidate's expertise shared, programs initiated and implemented, and direct involvement in activities that benefit specific sectors and the country in general.

3. **Leadership Qualities (20%)**

Consideration is given to the ability of the candidate to steer his/her company and/or civic organization to a position of strength and stability. Quantitative and qualitative standards such as company performance for the last three years, corporate image/reputations, and awards and recognition earned by the company/organization under the candidate's leadership shall apply.

4. **Integrity (15%)**

Consideration is given to the candidate's background and character and how he/she is perceived by his/her peers and the community in his/her country.

NOMINATION RULES

1. The Asia-Pacific Young Entrepreneur Award is open to all Primary Members' affiliated local chambers of commerce and industry (town and city chambers).
2. Nominees qualified to participate are those nominated and endorsed by a Primary Member. Each Primary Member may submit at most **two** nominees from among the local entries, and submit the same to the CACCI Secretariat.
3. The timeframe of achievement shall cover the period from **January to December** of the year prior to the presentation of the Award.
4. The Primary Member must complete and sign the Official Nomination Form. The entries must be documented with an Executive Summary of not more than 800 words about the achievement of the young entrepreneur nominee. It shall briefly state what he/she has achieved based on the given set of criteria.
5. The entries must be supported with the required documents specified in the Official Nomination Form.

SELECTION PROCESS

1. An Awards Committee shall be constituted by the CACCI Secretariat to evaluate the nominations. A **short-list of the five** most outstanding young entrepreneurs shall be made by the Awards Committee. The short list shall, in turn, be passed on to the Board of Judges, which is composed of representatives of the Primary Members who are willing to serve in the Board. The short-list must be received by the Board of Judges at least a month prior to the date of the final selection process.
2. The nominee must:
 - a. Agree to abide by the rules and regulations of the CACCI Awards Committee;
 - b. Be willing to give additional information required by the Committee; and
 - c. Be willing to personally appear before the Board of Judges to make a presentation or for interview, if required; and receive the Award, if selected.

I. INTRODUCTION

Endowed with the world's greatest water towers and with its resplendent biological diversity, South Asia has huge potential for Asia's food and water security if it is effectively mobilized and used.

Energy is the underbelly of any region's progress, with lack of water and environmental considerations a real threat to regional peace and security. There is, therefore, a need to seriously discuss, educate, advocate, encourage, prepare and plan for issues related to energy and water security and the imminent agenda for increased use of environment friendly clean renewable form of energy, now made even important due to the global warming menace.

Lots of efforts and best practices cases exist in the realm of hydropower and clean energy in the Asia Pacific region. There are many people and/or institutions who have rendered their services in pursuit of their contribution in the field of water and energy. It is now time to recognize their efforts and to honor them.

II. OBJECTIVE

Initiated by the CACCI Asian Council on Water, Energy and Environment (ACWEE) under the chairmanship of Nepal, the Asia-Pacific Hydropower and Clean Energy Excellence Award will be presented jointly with CACCI as a mark of appreciation and recognition to those person or institution that has contributed significantly to the sustainable promotion, support and development of Hydropower and clean energy in the Asia Pacific region.

The nominees could be individuals in the domain industry (entrepreneurs, subject specialists/experts, researchers, academicians, advocates/activists, Independent Power Producers, inventors, media personnel, bankers, authors) or institutions (private organization, Public corporation/agency, financial institution, research institution, Civil Society organization or media agency).

This award is an encouragement to recognize their efforts and to honor them for encouraging further endeavors. The winner of the Third Asia-Pacific Hydropower and Clean Energy Excellence Award will be announced during the Gala Dinner of the 32nd CACCI Conference to be held on 24 November 2018 in Istanbul, Turkey.

III. JUDGING CRITERIA

Strategic forethought, technical know-how and a determination never to let the customer down will be the hallmarks of the company/Projects that wins this award. Judges will evaluate nominees' successful development and implementation of a strategic plan that optimizes performance and growth while taking an aggressive, proactive approach toward a radically altered business and trading environment that moves to replace carbon content.

In addition to considering the past track record of an entrant, judges will be looking for evidence of industry-wide impact in the following areas:

- ⤴ Achievements
- ⤴ Challenges
- ⤴ Financial Results
- ⤴ Innovation
- ⤴ Operational Excellence
- ⤴ Safety
- ⤴ Strategic Vision

A. Achievements

Judges will expect to review a resumé of notable business, or other achievements by the company/individual.

B. Challenges

In assessing challenges, judges will want to know about:

- Technical complexity
- Technical innovation
- Environmental, social or political difficulties in the path of completing a project
- Complexity of access to finance

C. Financial Results

Judges would like to see:

- A detailed summary of revenue and net operating income (profits) for the different divisions of a business and the business as a whole over five years
- Growth figures and forward growth projections
- Customer growth figures where appropriate
- Figures for debt, credit-rating, market capitalization, and capital assets
- Specifically sound financing, In the case of energy-producing companies, reserve replacement figures
- A copy of the latest company or annual report

D. Innovation

A project, piece of technology, or business process will be judged innovative using the following criteria:

- Creativity: Does the entry represent a clear "break" with previously established methods or processes? Or is it simply an adaptation of existing techniques?
- Does the entry radically simplify or improve something? Or does the "innovation" simply consist of novelty?
- Is the innovation cost-effective and sustainable?
- Is the innovation likely to establish itself as standard industry practice within five years?

In the case of an individual, judges will look at the management style of the candidate:

- Does he or she propel their business through inventiveness?
- Does the individual encourage new ideas and risk-taking in their organization?
- How has the candidate demonstrated an ability to implement change?

E. Operational Excellence

Judges will look, where appropriate, for:

- Evidence of sustainable corporate growth
- Timely completion of projects
- Overall quality of project management
- Meeting of financial, business, construction and other targets
- Technical excellence
- Staff retention and turnover
- Safety record
- Environmental stewardship record

F. Safety

Judges will look, where appropriate, for

- Commitment to employee safety
- Commitment to community safety
- Commitment to environmental safety (Demonstrable benefit to the environment, good prospects for wider application, Sustainable benefit)

G. Strategic Vision

In judging the "vision" of a person, company or project, judges will look for:

- Evidence of a long-term, coherent set of aspired goals
- Evidence of a planned series of steps leading to achievement of the vision
- Evidence of real transformation as a result of the "vision"

In the case of a person, judges will look for ability to communicate the vision and inspire others with it

Judging Criteria for Individual

The award aims to recognize the valuable and demonstrable contribution that individuals, particularly those who don't otherwise have a high public profile, make to their workplace, business, colleagues or the wider community. It is open only to energy professional members or domain players.

The nominee must:

- Show demonstrable individual achievement within the energy industry, either through work or charitable endeavors that go 'beyond the call of duty'
- Show a commitment to the energy industry and its future
- Be a recognized as a leader, innovator, motivator or high achiever

IV. NOMINATION PROCEDURE

The CACCI Secretariat shall notify all CACCI Primary Members of the Award and the judging criteria and encourage them to submit their respective nominations.

Nominations shall be submitted through a CACCI Primary Member. No self-nominations by individuals or organizations shall be allowed. The Primary Member must complete and sign the **Official Nomination Form**.

Nominees will be requested to submit a 1,000-word synopsis on each project under the following five headings:

- Background - reasons behind the project concept
- Aims - what the project was designed to achieve
- Description and development - actions taken to carry out the project
- Impact and benefits - goal achieved through completion of project
- Reasons why the project should be considered for the appropriate award.

The timeframe of achievement shall cover the period from **January to December** of the year prior to the presentation of the Award.

The nominee must:

- ⤴ Agree to abide by the rules and regulations of the Judging Committee
- ⤴ Be willing to give additional information required by the Judging Committee
- ⤴ Be willing to make a presentation or for interview, if required; and receive the Award, if selected.

The Official Nomination Form – along with the supporting documents as stated above - must be received by the CACCI Secretariat by **May 31, 2020** and delivered to the Judging Committee by **June 30, 2020**.

V. JUDGING COMMITTEE

A minimum three-member Judging Committee shall be constituted to choose one winner. One member of the Judging Committee shall come from Hydro Solutions Pvt. Ltd. of Nepal, and the other two will be selected from any of the CACCI members who have not submitted any nomination, are deemed qualified by the CACCI Secretariat, and are willing to serve in the Committee.

The nominees shall be evaluated by the Judging Committee using a weighted grading system. The Committee's evaluation shall be made based on the supporting documents submitted by the nominees and, if necessary, through interviews of the nominees.

The nominee who receives the highest weighted grade shall be declared the winner.

The decision of the Judging Committee shall be final.
