The Ethiopian Petroleum Supply Enterprise (EPSE) has funds within the Procuring Entity's budget to be used for procurement of Consultancy Services for Formulation & Implementation of Integrated Enterprise Resource Planning (ERP) system & IT Solution in EPSE and invites sealed bids from eligible bidders.
2. This bid is intended for obtaining proposals from reputed Consultancy organizations (hereinafter called "Bidders") for the Formulation & Implementation of Integrated Enterprise Resource Planning (ERP) system & IT Solution in EPSE.
3. Bidding will be conducted in accordance with the Open International Competitive Bidding (ICB) procedures contained in the Procurement Directive of State Owned Enterprise (SOE's) of the Government of the Federal Democratic Republic of Ethiopia and is open to all bidders from eligible source countries.
4. The evaluation method adopted for awarding the contract of the Consultancy Services will be Quality and Cost Based Selection (QCBS) where award is given to the bidder that has scored the highest combined Technical and Financial Score among the bidders who qualified the preliminary examination and meeting the qualification criteria.
5. Under the single stage two-envelope bidding process, the Bidder shall not quote, disclose, or submit its price in the preliminary examination +pre-qualification +technical proposal or in any other manner, whatsoever, except as part of the financial proposal envelope. In case of any non-compliance in this regard, the Proposal shall be out-rightly rejected.
6. Bids shall be submitted into two separate outer envelopes, the first envelope containing the original and copy of the preliminary examination +pre-qualification +technical proposal envelopes; the second envelope containing the original and copy of the financial proposal envelopes. The bid security shall be contained in the original technical proposal envelope if it is not sent directly by the Bank to the Purchaser or handed over at the time of bid opening.
7. A complete set of Bidding Documents prepared in the English language may be obtained by any interested bidders, at the address below at 11(b) upon payment in cash, a non-refundable fee of Ethiopian Birr 500.00 (Five Hundred Birr Only) for each Lot.
8. Interested eligible bidders may obtain further information from EPSE and inspect the bidding document at the address given below at 11(a) from: 8:00 to 12:00 hours AM and 1:00 to 5:00 hours PM. A complete set of Bidding Documents prepared in the English language may be obtained by any

Bids must be accompanied by a bid security of 500,000.00 Ethiopian Birr or equivalent in any convertible currency which shall be valid for 28 days beyond the validity date of the bid and shall be in CPO or a Bank guarantee issued by a Bank established in Ethiopia. Late bids shall be rejected.
